## ROCKY POINT FIRE/EMS BOARD NEWS

The February meeting pulled together 4 Board members, Fire Chief, and 2 guests. Money matters and the minutes from the previous meeting sailed through and the group attended to the Chief’s report.

Volunteers responded to 1 MVC without transport, 1 medical without transport, and 1 medical with transport in January. They also logged 114 hours of training in trauma, in-house, pediatric, and case reviews.

Greg reported from the VFA, mainly consisting of the permit required for the generator installation. He will continue to report on that on-going process.

The only old business item was the 2<sup>nd</sup> ambulance search and purchase, which has been tabled for now.

Two big items guided the discussion in new business. First was the election of Board members. Two positions are up for election this year—secretary and treasurer. Contact Chad or any other Board member if you can be persuaded to throw your hat in the ring for the May election. The second was the end of Chad’s probation period as Fire Chief. Board members unanimously agreed that Chad has done a great job and is officially no longer on probation.
