

## ROCKY POINT FIRE/EMS BOARD

Four Board members, Fire Chief, and 3 guests attended the January meeting. After covering minutes and treasurer items, Chad reported 1 motor vehicle accident with transport and 1 medical call with transport that the volunteers responded to in the previous month. Volunteers also logged 254 training hours, which included a driving training class in Coos Bay and a firefighter I class.

The Board presented the 2013 – 2014 contract agreement between the Board and Fire Chief, who chose not to sign it and submitted his resignation. The Board has 30 days to find a new or interim Fire Chief.

Terry is working on flyers advertising the department’s need for volunteers. Rita checked on rules pertaining to highway advertising. The Board felt the public meeting inviting community input on recruiting volunteers to be a big help.

New Business addressed the need for notes and discussion from those who recently attended the SDAO conference.

Nick Ryan offered comments on the terms of the Fire Chief/Board contract agreement. Dr. Robert Melton, current department physician advisor, said his resignation from that position would be

effective when the current fire chief vacated his post.

Closing comments included a big thanks to Brianna Ryan for providing cookies and coffee at the January public meeting. The Board reiterated the need to recruit and train more volunteers.
